June-on-going 2020: COVID-19 Faculty/Staff Advisory Committee: There are 9 Faculty Senators who are on this committee facilitated by Dr. Hackett (Provost) and Dr. Weiss (Vice President for Administration)

July 2020: Anti-Racism Statement: Sub-committee of Faculty Senate met over the summer to discuss, read, learn and work tirelessly to draft, edit, and re-edit a statement which was reviewed by Faculty Senate Leadership, re-edited, reviewed by our colleagues Drs. Christopher Brooks and Aashir Nasim and then back to the original committee for final edit. The Faculty Senate voted to adopt the statement which was then posted on the FS web-site, Faculty Senators were asked to share the statement with their units/schools, and is incorporated into one of the 2020-2021 Faculty Senate Goals.

July 2020-ongoing: VCU Committee on Commemorations and Memorials: This committee reviewed documents and reports of commemorations and memorials on confederate commemoration and put forth recommendations. Those recommendations were available for public comment and the link was provided for all Faculty Senators to provide input. Recommendations will be forwarded to Dr. Rao.

June 2020-ongoing: Strategic Research Priority Plan (SRPP) committees: Faculty Senate representatives participate several of these sub-committees focused on implementation of the Strategic Research Plan. There are multiple sub-committees focusing on: Equity and Justice, Human Experience, Health, and Energy and Environments. Each committee is discussing action plans for implementation of the various initiatives for the research plan.

June 2020-ongoing: Return to Research Committee: Faculty Senate representative participates in this committee, which addresses concerns, issues and strategies facing the research enterprise during COVID-19 and return to campus.

June 2020-ongoing: VCU Board of Visitors Meeting: Faculty Senate is represented by the FS Past President and the President as an alternate. FS report is shared at each meeting with discussion.

June 2020-ongoing: Faculty Senate Past President, President, and Vice-President meet monthly with Dr. Hackett (Provost) for discussion of issues.

Purpose of Faculty Senate (NJ) 5 minutes

Purpose of the Faculty Senate is to represent the faculty On our web site it states:

Purpose: Connecting faculty to VCU administration and to each other

The purpose of the Faculty Senate shall be the furtherance and dissemination of knowledge and professional skills through teaching, study, research, creativity, exhibition, performance, and provision of community service. An additional objective will be to help insure through investigation, examination, comment and recommendation that the educational goal of the University is being realized by the policies and procedures employed in the University.

What does that mean? – Our FS By-laws provides more in-depth info:

- (The Faculty Senate represents the Faculty) to help create, maintain and protect a University environment conducive to growth of scholarship, creativity, learning, teaching, research, service and respect for human dignity and rights;
- We review and comment on proposed policies, programs and other matters that are proposed by the administration, school faculties, student organization and individual members.
- We develop and propose academic or educational policies which affect the university, the faculty, or students;
- We express opinions on University affairs as the Faculty Senate deems appropriate and necessary.
 - So in other words, we identify, articulate, and advocate for areas of interest to faculty, and we do this through the involvement of the faculty, Administration, and Board of Visitors, (and General Assembly.)

Role of the Faculty Senator:

- 1. Recognize as a FS you have a voice to help create, maintain and protect a University environment conducive to growth of scholarship, creativity, learning, teaching, research, service and respect for human dignity and rights
- 2. Represent your unit/school by attending meetings, bringing issues forward, providing updates to your school/unit, providing them with information that is important to faculty life...it is very difficult for us to send out information to all the faculty..another words, using a listserve with all the VCU faculty included...thus, we really count on you the senators to send out the info/requests to your unit/school. The faculty symposium info is a great example.
- 3. Serve a 3 year term as an elected senator; elected alternate senators serve 1 year. Alternate senators are always welcome to attend any meeting and if all the elected senators are present, the alternate senators have rights of discussion in FS but not voting.
- 4. When an elected senator is unable to attend a meeting, it is that person's responsibility to contact the alternate senate to attend the meeting. The alternate senator signs in on the FS attendance sheet and then designates who are they are replacing. When an alternate is

serving as the substitute, the alternate senator has voting rights.

5. Sign up for a committee – the real work of the senate is done within the committees and we ask each Faculty Senator to sign up for one committee...at today's meeting the chairs/cochairs will introduce themselves and the committees...Alternates are welcome to join...you don't have to but are more than welcomed.

Meeting Minutes from May are approved

Provost report Gail Hackett return to campus

Many resources over the summer to help faculty develop online courses. Continually monitoring, with a public health response team, heads of the student health office, but also faculty from medical school, as well as individuals incident command team.

Our student body is different than others, it is very diverse, high number low income students, first gen students, and minority students. This groups was the one that last spring had the most difficulty with the spring online courses. Ran surveys where student felt they could not return with personal instruction. Know from literature, from these groups, if they don't return, high risk for completely dropping out. So we need a personal presence for those students.

46% of the courses in person, only 17% of students in those courses. Tried to make allowances for faculty who wanted to be online.

Introduce Tom Briggs - Risk Management - Status of testing. Two type of testing, asymptotic testing, opt in pool trying to get 2% of population per month, 5% of residential students, not opt in for them. Symptomatic testing at old Ramsbike and Nelson clinic through referral by student health free of charge. Are seeing an increase in residential positive rates. Looking to add popup testing to test residential students. Also needed to open due to experiential learning. Honor's College, only started with 54 beds for isolated student. Health system already set up honors college for overflow, so we are using it for isolation. number of tests is too small need a full month to get good date. Two dorms have large numbers coming back. Symptomatic testing is 15% positive rate. 4400 students on campus. One issue with a spike in cases was due to student behavior, but the other main spike is not attributed by student behavior. Dashboard is a living document and will continue to improvement. No hard threshold. There is low change for dropping back to phase 1 closure. There are a number of factors, prevalence rate compared to overall region, what is isolation capacity, what is hospital is available. If we go to phase 3, then we still have community placements, and clinical students. So the essential courses will continue. Maybe a partial closure, rather than a full closure. Working with university relations in order to change message to students to help them be better partners in prevention and more cooperative. HVAC over the summer were all checked to make sure that they would be functioning properly.

Noble Triplett - Spring calendar

Calendar Options, recommendation from calendar committee. Regular start spring break 1 week earlier, Option 1, January 19. Option two delay start Jan 25 no spring break, SACCS requires a 30 week calendar. Same modalities offered. Also start online. Looking for input on opinions. Removing spring break might be problematic because of pace of teaching or for experiential learning/volunteering partnerships. Exceptions for in person if we start online would be clinical or maybe other courses. January Intersession, still offered, also another option for intersession so instead of 2 weeks, now a 3 week option. Down by 600 freshmen, most the vulnerable students. Word document coming

Request for Faculty Representatives:

1) The VCU Safety and Well-being Advisory Committee

is requesting faculty to consider serving on this committee, which has been charged with defining and instituting the components of a new transformational model for public safety and wellness across campus, independent of VCU Police. We seek dedicated candidates who feel compelled to lend us their expertise and are willing to commit to serving as a member from September 2020 to May 2021. Anticipate the committee will meet a minimum of twice a month, concluding after findings are presented to the VCU Board of Visitors and VCU Health System Authority Board of Directors next May. Andrew Daire — dean, school of education and Sheryl Garland, VCU Health system will lead the committee as co-chairs

2) The Domicile Appeals Committee requests a faculty member to serve as a voting committee member on this new committee. This Committee has the final authority at the university for all appeals related to domicile for tuition purposes. The responsibility for this committee has recently transitioned from Student Affairs to Strategic Enrollment Management (SEM). The committee meets once a month. The length of the meetings can range from a couple of hours to closer to four or five hours. It depends on the number of appeals the committee needs to review. Also, the appointment is for a 2-year term, although committee members can be reappointed for multiple terms.
