#### Faculty Senate News (Dr. Nancy Jallo, President Faculty Senate)

- Approved Minutes from last September meeting
- Attended first meeting of the OVPRI Strategic Research Initiative committee. Units have been requested to provide a one page report of the priorities of their unit to an upcoming all day retreat where they will review all the one page reports, and develop a list of strengths and opportunities to focus.
- During a meeting with the Provost, Provost Hackett mentioned concerns that

had been expressed to her that some faculty were unhappy that ~~with~~ the VCU ID only saying Staff or Student. A motion was proposed and seconded to recommend to her, that the two-classification system be changed to add a faculty designation. The motion was discussed and was passed with 2 opposed, and 4 abstentions.

#### Provost's report (Dr. Gypsy Denzine, Senior Vice Provost Faculty Affairs)

- Several executive searches going on currently and strongly encourages faculty to be engaged in the open forums and overall process
- The Term Faculty Taskforce has had its first meeting. A survey will be forthcoming to solicit input. So be on the look-out for a survey.
- The results of the COACH satisfaction survey are in the Provost's office and are being reviewed. The results are going to be shared later this semester. The survey was hosted by Harvard and had nearly 37% response rate from VCU faculty.
- In Oct 10, the Provost's office will host a Tenure and Promotion Reception for all newly promoted faculty. Details will be forthcoming.
- In November, there will be an Adjunct Faculty development day.
- Course Redesign is underway with four courses (a course in MATH, Entrepreneurship, Art and Nursing). Expect a funding opportunity in the spring for \$35K from the Provost's office to suggest and help support redesign of a course which has a high percentage of students struggling.
